


Health Maintenance Organization (HMO)



- HMO plans require you and each family member to select a Primary Care Physician (PCP) and medical group. Additional care from specialists, hospitals, surgeons, etc. require a referral from your PCP medical group.
- If you do not select a PCP when you initially enroll Aetna will assign one for each of your family members.
- Each family member's PCP will be printed on the ID cards. You will receive plastic ID cards when you initially enroll, and then digital ID cards if you make any subsequent changes. If you would like a new plastic ID card, please contact Aetna at 1-833-576-2494.

Aetna HMO Plan (available in 33 states - see map below)





AVN and HMO Tips

- You must get referrals from your PCP and approval from your medical group for most of your specialty care. You cannot just go directly to any in-network provider.
- Your PCP will generally refer you to a specialist within the same medical group.
- Referral/authorization requests for AVN/HMO members are reviewed by your medical group not Aetna.
- Your PCP or specialist will refer you to a participating Lab/X-ray provider that is part of your medical group. You can also ask them to send your lab work to the national chains Quest or LabCorp.
- AVN/HMO members must obtain prescriptions from an in-network pharmacy (e.g., CVS, Costco, etc.) or via CVS Caremark Mail Service Pharmacy. The pharmacy network is called Aetna National Pharmacy Network.
- AVN/HMO members can self-refer to in-network acupuncturists and chiropractors. PCP approval is not required. To locate an in-network provider log into www.aetnaresource.com/p/cosm and search for Alternative Medicine.



OAMC (PPO) Tips

- You choose every time you go to the doctor whether you want to go in-network or out-of-network.
- In-network providers will usually file claims for you and obtain precertification when necessary.
- Out-of-network providers may require that you pay the full charges and submit a claim to Aetna.
- When you go to an out-of-network provider, it is your responsibility to obtain precertification from us for any services and supplies on the precertification list (e.g., hospital stays, complex imaging). Refer to your plan booklet for the complete list.
- You may use any Lab/X-ray provider, but your benefits will be higher if you use an in-network one. You can also ask your physician to send your lab work to the national chains Quest or LabCorp, which are both in-network.
- You may obtain prescriptions from any licensed pharmacy, but your cost will be less when you use an in-network one (e.g., CVS, Costco, etc.) or via CVS Caremark Mail Service Pharmacy. The pharmacy network is called Aetna National Pharmacy Network.

Out-of-Area Dependent Children

AVN/HMO

If you have children going to school or living with a parent outside of the California Aetna AVN or HMO service areas, we can cover them.

- If they reside in another Aetna HMO network service area (e.g., Phoenix, Arizona) they can select a primary care physician (PCP) in that area.
 - Please provide The County with your dependent's local address (e.g., in Phoenix, Arizona).
 - Aetna will enroll your dependent in the same AVN/HMO plan as you with your SSN and the same Aetna W ID #.
 - Call the Aetna Concierge team at 1-833-576-2494 when you receive your dependent's ID card and select the new desired PCP in their area.
- If they do not reside in another Aetna HMO network service area, we can enroll them in a special Out-of-Area Dependent PPO Plan.
 - Please complete the special Out-of-Area Dependent PPO Plan enrollment form (available from the Benefits Office) and provide the dependent's local address.
 - Your dependent will be enrolled separately under their own SSN and issued their own Aetna W ID #.
 - Your dependent's benefits will mirror the County's OAMC PPO \$200 plan. The network will be Aetna's nationwide Open Choice PPO.

To find out if your dependent resides in another Aetna HMO network service area please call the Aetna Concierge team at 1-833-576-2494 and provide the zip code.

Managed Choice POS (Open Access) – aka OAMC PPO

Members in these plans have access to Aetna's nationwide network, so your dependents can use In-Network providers in any state.

If there are no In-Network providers available your dependents may use any licensed provider and will be covered at the In-Network level for emergency/urgent care, and the Out-of-Network level for everything else.
